HIS IS THE VISION DEVELOPED AT THE VISION 2030 SYMPOSIUM HOSTED BY AAG in partnership with Alberta Seniors and Housing and attended by over 300 people. It is the focus of AAG work and has already resulted in a AAG policy recommendation document - " Older Albertans Living Well: A Call to Action to Enhance Care and Services". This paper includes immediate recommendations in key areas including staffing and keeping older Albertans safe in time of pandemic and has been presented to both the Ministry of Health and the Ministry of Seniors and Housing. This has led to in depth conversations which we believe will positively influence the evolution of a quality system. The paper was distributed to each member by email and is posted on the AAG website. Thank you to the experts who so willingly volunteered expertise for content and writing.

AAG continues to conduct our business virtually with full board participation and movement on three main goals including:

- 1. Further refine governance and operational infrastructure of the Association,
- 2. Support the creation of forums and opportunities for policy discussion and development to improve the quality of life of older adults by collaborating with other stakeholders and the community at large,
- Increase the visibility and profile of AAG.

Significant work is occurring in each of these goal areas with a distinct team of the Board focused on each goal.

#### FEATURE ARTICLE

Sharon Anderson

SENIORS SERVICES SYMPOSIUM identified family caregiver supports as an important policy issue. Now, COVID-19 has emphasized family caregivers are an integral and increasingly overburdened part of the health care system. Our survey of the impacts of COVID-19 on Alberta Family Caregivers demonstrated that the gap between what family caregivers need and what is provided had grown wider since COVID-19 began. In Alberta, we have been working on solutions. In the Older Albertans Living Well: A Call to Action to Enhance Care and Services, the AAG has recommended development of long-range directional policies and immediate actions to improve seniors care and services in Alberta. The recommendations are like those in our Survey of the Impacts of COVID-19 on Alberta Caregivers Report. In 2014, Jasneet Parmar, Jayna M. Holroyd-Leduc, Wendy Duggleby, Suzette Bremault-Phillips, Leslie Charles and many others began consulting with Alberta stakeholders--researchers, family caregivers, caregiver associations, clinicians, health care administrators, and policy makers to co-design the path towards family caregiver supports.

Stakeholders these meetings at [2-7]recognized that family caregivers and their situations are diverse. Family caregiver's needs over the care trajectory. assumption was that no one person or organization could meet family caregivers' needs. All stakeholders need to work together to collectively address family caregivers needs along the entire care trajectory. recommended the health workforce be trained and mandated to support family caregivers as well as the Albertans they care for. This is a population health approach to helping family caregivers to access supports in a timely manner all along the care trajectory.

Within the provincial government, the Caregiver Supports Working brings together six Alberta Ministries, researchers, health and community providers, and community organizations to work collaboratively to support family caregivers. The Caregivers Alberta received \$3 million in grants from the provincial government to expand programs and resources for family caregivers. There is now a pan Alberta Caregivers Focused Coalition of multi-level stakeholders with interests in family Caregiving. The group joins the CORE Alberta platform on November 24.





Dr. Parmar and her multi-level interdisciplinary stakeholder team have co-designed competency-based Caregiver Centered Care Health Workforce Education to educate health providers about personcentered care for family caregivers. The Foundational Caregiver Centered Care Education was just launched online at the <a href="Caregivercare.ca">Caregivercare.ca</a>. The e-learning management website designed by the Academic Technologies Department, Faculty of Medicine and Dentistry at the University of Alberta. The education takes about an hour and is free.


