VIVIEN LAI CHANGE MAKER AWARD 2025 INNOVATION IN COMMUNITY SOCIAL/HEALTH SERVICES INTEGRATION

Vivian Lai had a long career with the Alberta Government in planning and policy development that shaped the continuing care system. She worked to ensure that Alberta's Continuing Care System focused on quality of life for staff and Albertans needing care. She was a committed and influential member of AAG, having served as President of the Edmonton Chapter and the Alberta Board. Vivien was a visionary leader on the Alberta Association on Gerontology's (AAG) Future Policy Forum/Culture Change Project and Stakeholder Collaborative Committee initiatives where she sought to foster a culture and community conducive to change. Her contributions will have influence on the evolution of continuing care and health aging in Alberta, as well as on those individuals who had the honor of working alongside her on many projects and initiatives.

DESCRIPTION OF AWARD:

The purpose of this award is to recognize individual or team merit in support of Alberta's transformative journey in community social/health services integration. The Vivien Lai Change Maker Awards were developed as part of the work undertaken by the Alberta Association on Gerontology's (AAG) Future Policy Forum/Culture Change Project and Stakeholder Collaborative Committee. The recipient(s) receives a certificate and will be featured in the AAG website "New and Views". Nominees who are not recipients will receive a certificate of recognition.

CRITERIA:

The criteria which will be used to assess nominations include one or both of the following:

Innovations:

- A focus on people in communities, moving away from a focus on inputs (e.g. health system, payers, buildings, and clinicians) towards outcomes for people.
- Embracing cross-sectoral actions as key to integrated community systems and connections that enhance access to community services.

Other Criteria:

- Demonstrate collaborative engagement—cross-sectoral initiative; multi-party implementation; citizen engagement.
- Development based on knowledge mobilization as well as integration of evidence and experiential insights.
- Clarity of intent and impact measures.
- Nominees should be **front-line transformational leaders or service and support/service development teams**, rather than senior organization administrators.

NOMINATIONS:

- Nominations consist of a completed Nomination Form and two (2) letters of support.
- Nominees from rural, urban settings, small and large organizations are encouraged.

ANNOUNCEMENT:

Recipients of the Vivien Lai Change Maker Awards will be announced at the Annual General Meeting, and will appear in *AAGmag*, and AAG website.
